- 1. Kill switch (except manual control)
- 2. Aerated Live Well
- 3. Coast Guard approved safety equipment and H.P. rating No waist life preservers permitted.
- 4. All boats **must** be checked in and in the water by **6:00 a.m.**
- 5. Proof of \$100,000.00 (minimum) liability insurance must be available at boat inspection or attached to application.
- 6 Headquarter waters for Choptank Nanticoke & Pocomoke only: Off Limits. 12:01AM Saturday the day before Tournament. All others No Off Limits
- 7. Each team is allowed one substitute partner during the year.
